### 2022 Scholarship Eligibility Requirements

#### CANDIDATES

Candidates must be incoming seniors who have currently enrolled and been accepted in an upper-division public relations, mass communication or related track at an accredited college or university within the state of Florida and slated for graduation not earlier than the following fall semester. Candidate must be a full-time student with a minimum grade point average of 3.0 on a 4.0 scale. An unofficial transcript from your school must be submitted with your application, résumé and essay as outlined below. Membership in FPRA is not required but recommended. Students who are not currently members of FPRA are invited to submit a completed membership application along with their scholarship application. Student membership dues are \$30. #### APPLICATION

Please type or fill out the student scholarship application in ink (print legibly). The application must accompany your transcript, résumé and response to an essay question related to the public relations field. Select one of the four questions presented below for your essay. Choose the question that best suits your interests in public relations. The essay must be original, typed, double-spaced and no longer than two pages, approximately 800 words—answer **one** of the following questions.

- 1. What do you think is the most critical issue or trend affecting PR today and why?**
- 2. Do you think social media can be an effective medium for changing a target audience's way of thinking and ultimate behavior? Provide a real-world example(s) to support your answer based on your response.**
- 3. Over the last ten years, how has the PR profession changed; where do you see the profession going in the next ten years, and why?**
- 4. What do you think was the most valuable aspect of your Public Relations (Mass Communication or related field) education, and how has this part of your education prepared you to enter today's job market?**

#### SELECTION PROCESS

The awardees of the FPREF Scholarships (Dr. Bob Davis, APR, CPRC Scholarship and Dr. Jay Rayburn, APR, CPRC Scholarship) will be selected based on a recommendation from the Scholarship Committee. The honorees will be notified the week of April 25, 2022.

**AWARDS**

FPREF will award scholarships based on the availability of funds. A minimum of two \$1,500 scholarships will be awarded annually. The awardees will also receive a certificate in recognition of their achievement and will be honored during the Presidents' Luncheon at the 83rd FPRA Annual Conference on August 8, 2022. In addition, the selected essays may be published in FPRA's statewide electronic newsletter.

**DEADLINE**
